INFORMATION ON OBTAINING A F-1 STUDENT VISA

As an international student who will be temporarily residing in the United States, you are required to comply with United States immigration laws. The United States strictly enforces a very detailed set of rules and regulations governing foreign nationals. Your adherence to the requirements and procedures articulated below will help you to avoid unnecessary difficulties. Please read the information below carefully.

SEVIS

The Student Exchange and Visitor Information System (SEVIS) is an online database that connects the U.S. Citizenship and Immigration Services (USCIS) with U.S. colleges and universities by providing information on international students and scholars. Applicants for F-1 and J-1 visas are required to pay a one-time SEVIS fee of \$350 to supplement the administration and maintenance costs of SEVIS.

F-1 Student Visas

Having a U.S. visa is like having a key to enter the country. The expiration date on your visa is the last day you may enter the United States from abroad. You need a valid visa every time you enter the country. Depending upon the type of visa you use to enter the U.S., you are subject to different guidelines in order to "maintain status" or remain in this country legally. The Graduate and International Programs office can help guide students through the application for F-1 student visas.

Form I-20

To apply for an F-1 visa, you will need a Form I- 3 & HUWLILFDWH RI (OLJLELOLW\ IRU 1RQL 6WDWXV $^\prime$ 8VLQJ WKH 6(9,6 V\VWHP WKH *UDGXDWH DQG ,QWHUQDWLRC the Form I-20 under the following conditions:

- 1. You have been fully admitted into a program of study at the law school;
- 2. You have shown proof of financial support for the first year of study. You must submit a complete Certification of Finances form along with the required supporting documents.
- 3. You have paid your tuition deposit through your portal.

PROCESS

Step 1: Certification of Finances ±This form is used to show proof of financial support for your first year of study. You must demonstrate sufficient funding to cover all expenses including tuition, fees, books and living expenses. Funding may come from your own personal account, a private sponsor's account and/or scholarships or loans that have been approved. In addition to filling out the form, you will need to provide adequate verification of the funds. Verification documents include:

- x Letter from your bank or your sponsor's bank stating the available funds. The letter must be on official letterhead and dated within the last three months; and/or
- x Official award letter stating the amount and duration of the scholarship/grant awarded, if applicable; and/or
- x Loan approval letter from the granting institution, stating the loan amount, if applicable.

Copies of the financial verification documents may be sent to the law school (by email is fine). The originals should be retained by you so that you will have them available when applying for your visa at the U.S. embassy/consulate and for use at the port of entry.

Step 2: SEVIS Fee - Once you have obtained the Form I-20 from the law school, you will need to pay the required \$350 SEVIS fee, get the fee receipt and make an appointment at the embassy/consulate. To pay your SEVIS / 612 79iq0 0 46 (g)-334 (e) JETh6 (g)-344 (e) J
